### The State in Modern Turkey and Iran, 1800–2020 Instructor: Cevat Dargin

Understanding the processes of modern state making in Turkey and Iran in relation to one another and the larger world around them is crucial for a deep understanding of the Middle East, past and present. Turkey and Iran share one of the oldest borders in the Middle East, which is based on a delicate balance of power. The two countries are heirs to rival Muslim empires, which ruled over most of the Muslim world for centuries. Iran took a radical turn towards Islamism in 1979, but Turkey's gradual path to Islamization since the military coup in 1980 is closing the gap. Both countries have imperial nostalgia: both have uneasy relations with the Arab world and the West: both are heavily involved in gender politics; both face profound environmental challenges. In the longue durée, however, the desire to preserve and maintain the state in both countries cuts across and overrides all other priorities, including religion.

The preservation and maintenance of the state across time, dating back far beyond the Islamic era, is an essential myth in both Turkish and Persian nationalism. Indeed, Turkish and Iranian experiences with nationalism, democracy, and the West show striking parallels: the two countries have gone through analogous developments with

regards to confessionalization (Sunni versus Shi'i), (anti)colonialism, and modernization and have occupied similar positions in global power dynamics in relation to Russia, Britain, the Unites States, and China. Despite their differences in religion and language, they have strong cultural and economic ties and are home to shared ethnic and religious groups that are crucial to the domestic and interstate affairs of both countries.

Based on a comparative and multidisciplinary methodology, this course explores the making of the modern state in Turkey and Iran from their centralization efforts in early nineteenth century up to the mass protests in both countries in 2010s. Weekly readings and lectures are organized around common themes such as nationalism, colonialism, war, Islamism, gender, and environment that override conventional periodizations and geographical demarcations. The state will be at the center of our discussions, but not necessarily through the developments at the center. We will creatively engage with underrepresented subjects and themes pertaining to the making of the state in different ways. The course explores the political, economic, social, and cultural histories of the subject matter using academic writings alongside multimedia sources. It strives to apply and enhance the principles of inclusion, equity, and justice in terms of the material included and the ways in which lectures are imagined and designed.

Prior knowledge of the modern Middle East is desirable but not required.

# **Course Requirements and Grading**

Weekly response papers (max 1 page), including preferred discussion questions (25%). Participation (25%).

A final paper comparing modern state making in Turkey and Iran through a theme discussed during the semester (50%).
